

PERSONAL DATA PROCESSING NOTICE

(in accordance with EU Regulation 2016/679 and Law no. 190/2018, Romania)

1. What are personal data?

 - legitimate interests of the Company (Art. 6(1)(f)).

6. How data are collected

Data are collected:

- Directly from you (contact forms, registration forms, email correspondence),
 - Indirectly, via cookies and similar technologies.

7. Data transfer and storage

Data may be transferred to contractual partners or public authorities only as permitted by law. The Company implements appropriate technical and organizational measures to protect your data against unauthorized access, loss, or unlawful disclosure.

8. Your rights

Under GDPR, you have the following rights:

- Right of access (Art. 15),
- Right to rectification (Art. 16),
- Right to erasure (“right to be forgotten”, Art. 17),

- Right to restrict processing (Art. 18),
- Right to data portability (Art. 20),
- Right to object (Art. 21),
- Right not to be subject to automated decision-making (Art. 22).
